The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

1. Bidder should submit all the documents and Annexures as per the attached specification document.
2. Bidder should quote for all the items mentioned in the BOQ
3. Bidder should provide the minimum 5 years warranty for the furniture items.
