1. The semester fee structure is for 6 months.
2. \*The dining charges are calculated assuming Rs. 145 per day for 5 months and the balance will be adjusted once a semester. Mess Charges will be as per actuals. If a student is not on campus during vacation, the balance amount of mess charges collected will be adjusted or refunded to the student at the beginning of next semester.
3. \*In Pt. 2.4, Rs 22,000/- (Dining Charges for August-December) is exempted for students who are not on campus. For students on campus, it will be applicable.
4. Hostel Rent charges/Electricity Charges/Water Charges during vacation period, will be refunded to the student only if the student vacates the room and hands over the room keys to Hostel Office.
5. Pt. 2.4 and 2.5 are exempted for Newly Registered Students (2021 Enrolled Students) and will be collected as and when they avail the hostel and mess facilities
6. The Medical Insurance is for Rs. 1,50,000/-
