Sub: Recruitment to the post of Technical Superintendent – Computer Center on Deputation Basis/ Short Term Contract – reg.

The Indian Institute of Technology Hyderabad (IITH), an Institute of National Importance established by an Act of Parliament under the aegis of the Ministry of Education, Government of India, invites applications from eligible officials of Central/State Government Departments, Central Autonomous Bodies, Government Research Institutions, Universities, Government or private Organizations of high repute for appointment to the following post on deputation basis initially for one (1) year, which may be extended annually up to a maximum of three (3) years, based on the requirement of the Institute and performance of the incumbent. Further, based on the review of performance and subject to fulfillment of the Institute's rules and regulations, the selected candidate may also be considered for absorption in due course.

Eligibility Conditions: Essential Qualifications and Experience:					

(a) Educational Qualification:

First Class in B.E./B.Tech./MCA/M.Sc. in Computer Science / Information Technology / Electronics from a recognized University/Institute.

(b) Experience:

(i) Holding an analogous post on a regular basis;

OR

With at least five (5) years of regular service in Central/ State Government organizations/ Autonomous Bodies/CFTIs/Research Institutions/Universities or in a reputed private organization.

AND

(ii) Experience in any of the following domains: Network Administration and Management (Routing, Switching, VLANs, IP Addressing), Maintenance of Campus-wide Fiber, LAN and Wi-Fi Infrastructure, Network Security, System Administration (Linux/Unix and/or Windows Servers) and Data Center activities.

Note: Please note that the current incumbent of this advertised post is being relieved on technical resignation for joining another organization and will retain lien on the post at IITH until completion of probation in the new organization or for a period of two years, whichever is earlier. If the lien-holder returns to IITH during the lien period, the candidate selected on deputation will be reverted to their parent organization, and in case of a short-term contract, the contract may be terminated.

4.1 Candidates serving in Central/State Government Departments, Autonomous Bodies, or PSUs shall forward the hard copy of the online application through the proper channel, along with:

(i) Self-attested copies of educational qualifications and experience certificates.

(ii) APARs of the last five years (or) for the no. of years of service as applicable.

(iii) A Certificate by the Employer (Annexure-I).

4.2 Candidates from private sector/contractual positions shall apply online with relevant supporting documents. They are not required to send hard copies.

5. GENERAL INSTRUCTIONS:

- 1. The applicant must be a citizen of India.
- 2. Candidates must ensure that they fulfill all eligibility conditions before applying.
- 3. Candidates applying on a deputation basis must hold the post on a regular/permanent basis in their parent cadre.
- 4. Internal (IITH) candidates are not eligible for this deputation post, as deputation involves movement from outside the parent cadre.
- 5. The cut-off date for determining age limit, qualification, and experience shall be the last date of submission of the online application.
- 6. Candidates must upload a properly signed Certificate by the Employer (Annexure-I) without which the application shall be summarily rejected.
- 7. Incomplete applications or those received without the required enclosures shall be summarily rejected.
- 8. Shortlisting shall be based on qualifications and experience higher than the minimum prescribed. Merely fulfilling eligibility does not entitle a candidate to be called for an interview.
- 9. The Institute reserves the right to not fill the post or to reject any/all applications without assigning any reason.
- 10. Experience certificates must clearly mention designation, nature of duties, period of service, and pay details. Documents such as offer letters or pay slips will not be accepted in lieu of experience certificates.
- 11. All future correspondence shall be made through the candidate's registered email ID. No interim correspondence shall be entertained.
- 12. The Institute reserves the right to conduct a written test/skill test/interview as applicable.
- 13. Candidates must produce all original documents along with self-attested copies at the time of the interview.
