ANNEXURE-II

1. Students with disabilities are provided the following services in the Hostel

a) Allotted rooms in the ground floor of the hostel blocks, which are bigger and spacious and built for the convenience of them.

b) For every 02 students,one dedicated spacious bathroom/Toilet with SS rail support within it.

c) A dedicated attendant 24*7 for the physically disabled students.

d) A dedicated motor vehicle four-wheeler with a dedicated helpline is arranged for these students for movement within the campus.

e) Every ground floor block has ramp to move to their rooms with their motorbikes/tricycles.

f) Medical clinic with well-equipped facilities 24*7 and night duty doctors/attendants.

g) 02 in no's ambulance service is provided 24*7 for all students.
