Grounds of the appeal:

Provided Incomplete, Misleading or False Information

Appeal Text:

IIT Hyderabad is implementing reservation in favour of SC, ST, OBC and EWS without appointing a single person from these categories in library staff. Out of total 8 employees none is from reserved category. At present there is no representation at all to persons of these category in Library since reservation is in force for the last 70 yrs for SC and ST and since 1993 for OBC. On what basis IIT Hyderabad can claim for implementing reservation policy. Information provide is false and misleading.

Disposal of Appeal:

1.IIT Hyderabad is strictly implementing Government of India reservation rules in direct recruitment and promotions of non-teaching staff.

2.As per DoPT Office Memorandums No.36012/2/96-Estt(Res) dated July 2, 1997 and No.36039/1/2019-Estt (Res), cadre wise post based reservation roster is being maintained. A model roster prescribed by DoPT up to 13 posts are attached herewith as Annexure for information.

3. Appeal against the decision of the Appellate Authority lies with the Central Information Commission, Room No.326, 'C' Wing, II Floor, August Kranti Bhawan, Bhikaji Cama Place, NEW DELHI 110 066.
