While the response provides the split up of the no. of patents, designs and copyrights in which IIT Hyderabad is an applicant, it does not provide the split up of Indian and Foreign applications as requested in the RTI.

I request the FAA to direct the CPIO to provide the specific information sought in RTI No. IITHY/R/E/23/00127.
