# **CORRIGENDUM / ADDENDUM**

It is notified to all the prospective bidders that with reference to the tender number IITH/103/MS/Tender/HKS/2022, dated.12.03.2022 the following changes are being made to the tender document:

1. The following content of the *point no.10.3 at Page no. 4 of the tender document* is amended as follows:

- 2. The following condition has been included *as point no.* **11.2(a)** *under point no.***11.Bid** *Evaluation Process. at Page no. 5* of tender document:
  - 11.2(a) In order to ensure the quality of services, the Tender Committee worked out the reasonable Service charges. The minimum reasonable service charges will be disclosed before opening of financial bids. The bids received with the service charges greater than or equal to the reasonable service charge shall only be considered for final evaluation. The bids with the service charges less than the minimum reasonable service charge notified will be treated as disqualified/invalid.
- 3. The following condition has been included *as point no. VIII under point no.10.3 at Page no. 4* of tender document:
  - VIII) Those bidders having experience with IITH during the period 01.01.2017 to 31.12.2021 should mandatorily obtain Experience and QAS certificate from IITH and include the same in their bid, failing which the bid stands disqualified.
- 4. The following condition has been included *as point no. 10.4(a) at Page no. 4* of tender document:

10.4 (a). Bidder should have a Registered/Branch office at Hyderabad. [proof to be enclosed in the technical bid]

5. In compliance of *Para no. E.1. at Page no. 13 of the tender document,* the successful contractor should deploy his representative/field officer at IITH, whose wages shall not be less than the minimum wages under skilled category. These wages are to be borne by the contractor from their service charges.

- 6. Bidders are expected to provide the workers with the uniforms of good quality. The **revised format of** *Annexure-III* **is enclosed herewith.**
- 7. The bidders should provide a reasonability statement in support of the service charges quoted in the format **Annexure-IV** given long with this corrigendum, **failing which the bid stands disqualified**.
- 8. The Bidder having any exemption from the standard rates of TDS should enclose the same along with their bid to enable the IITH to decide on the reasonability of the service charges quoted by the bidder.
