Inter IIT Sports Meet 2025

Document for Livestreaming & Broadcasting Services

1. Introduction

The Organizing Committee of the Inter IIT Sports Meet 2025, hosted by IIT Hyderabad, invites bids from reputed and experienced agencies for providing broadcasting, live streaming, and video production services for multiple sporting events conducted during the Sports Meet.

The objective of this tender is to ensure a HD-quality, multi-platform broadcast coverage of all key sporting events, enabling both on-site audiences and remote viewers (alumni, students, and sports enthusiasts) to experience the events seamlessly.

2. Scope of Work

The selected agency shall be responsible for the end-to-end management and execution of broadcast operations for the Inter IIT Sports Meet, including but not limited to:

A. Event Coverage

- Live broadcast of all major sporting events, including:
- Football
- Volleyball
- Cricket
- Hockey
- and other events as listed in the final schedule.
- Coverage of Opening and Closing Ceremonies.
- Daily highlight reels.

B. Production Requirements

- Multi-camera setup for each event.
- High-definition (HD or higher) video output.

- On-site production control with mixing, graphics, and replay facilities.
- Commentary and scoring overlays are integrated in real-time.
- Drone coverage for outdoor events.

C. Live Streaming and Distribution

- Simultaneous streaming on official platforms:
- YouTube / Facebook / OTT partner.
- Set up of a streaming control room at each venue.

D. Post-Production Deliverables

- Event-wise edited highlights.
- Final compilation video summarizing the entire Sports Meet.
- Delivery of all raw footage in SSD/hard drive format to the Organizing Committee.

3. Duration and Schedule

• Event Dates: 14th Dec 2025 to 21st Dec 2025

• Broadcast Period: Full duration of the event schedule.

5. Terms and Conditions

- The vendor shall provide all the listed services for 8 days with the same equipment and setup.
- Additionally, the vendor must provide services for the Opening Ceremony, Closing Ceremony, Pro Show, cultural events, etc.
- If the Organising Committee requests up to two additional live streams, the vendor must also provide these.
- For each and every game, the vendor must have a backup plan in place in case of any failure.
- If the vendor fails to provide any of the services or compromises the quality of the live streaming, the Organising Committee reserves the right to deduct the amount from the contracted payment.
- All matches will be live streamed on the Inter IIT Sports Meet YouTube channel and other official social media platforms of the Inter IIT Sports Meet.
- The vendor is not allowed to broadcast the live stream on their own channels or on any other third-party channels.
- The live streaming quality must match the standards of international sports broadcasts.
- No copyrighted items/songs or any other copyrighted material may be used in the live streaming without proper licence. The vendor must have all necessary copyright licences for any material used.
- The vendor must obtain approval from the Organising Committee for all overlays to be used in the broadcast.

- Overlays and the replay system must follow our branding guidelines. Without adherence to these guidelines, the vendor is not allowed to use any overlays. Using branding-compliant overlays is compulsory.
- The use of overlays is compulsory for the vendor.
- Overlays must comply with all applicable international laws and practices. The standard of overlays used for international cricket, football, hockey, and volleyball should also be followed here. No compromise on this will be accepted.
- An internet point will be provided by the Organising Committee at each ground. The vendor must take the connection from that port and use the internet accordingly.
- Only the Ethernet point will be provided. No cables or other accessories will be provided; the vendor must bring all necessary equipment.
- A maximum of three common drones may be used across all grounds.

6. Eligibility

- The vendor must have a minimum of 4 years' experience in broadcasting/production of at least 15 sporting events with recognised associations and/or state/central governments.
- The vendor must have prior experience of at least 2 multi-sport events and 1 university-level tournament.
- The vendor must possess or have access to:
 - o Professional-grade cameras and production equipment.
 - Technical crew for all required venues.
- The vendor must be a Private Limited Company, LLP, Partnership Firm, or Registered Sole Proprietor.
- Annual Turnover of R.40.00 Lakhs. In this connection, a certificate from CA should be enclosed.
- The vendor must provide client references from at least three projects.
- The Organising Committee reserves the right to accept or reject any or all tenders without assigning any reason.
- All work must comply with local laws and required permissions (e.g., drone usage, copyright).
- The agency shall ensure non-interruption of the broadcast and maintain adequate backup equipment.
- All broadcast rights and content shall remain the property of the Inter IIT Sports Meet Organising Committee 2025.
- Meals and lodging for the crew will be provided by the organisers for the duration of the event.

7. Submission Requirements through online portal.

Bidders must submit:

- 1. Technical Proposal, including:
 - Company profile and experience.
 - Details of equipment, crew, and technical plan.

- Sample links or references to previous broadcast work.
- Incorporation documents
- Work orders or completion certificates of similar projects.

2. Financial Proposal, including:

• Itemized cost estimate (per event and total as shown in the below table).

Shortlisted vendors may be called for a presentation or technical demonstration to oversee their technical capability, quality of the output.

9. Financial Criteria

Financial bids for those who are qualified in technical criteria will be opened and L1 will be awarded. The BoQ may be downloaded from the CPP portal and upload the same on the CPP portal only.

10. Earnest Money Deposit:

An **EMD of Rs. 1,00,000/-** (Rupees one lakh only) in the form of the Demand Draft in favor of The Director, IIT Hyderabad payable at Hyderabad is required to be submitted along with the quotation. Bids without EMD will be summarily rejected.

11. Security Deposit:

The successful bidder will have to submit a security deposit of 5% of the contract value in the form of a security deposit or bank guarantee in the name of "The Director, Indian Institute of Technology Hyderabad", within 7 days of awarding the contract. The Performance Guarantee shall cover the entire period of contract and shall remain valid for a period of 30 days beyond the period of contract.
