Sir,

With reference to the tender dated 08.10.2024 submitted by you against the NIT referred above and it is hereby informed that the approval of the competent Authority of IIT Hyderabad for the award of contract to you for "supply of ambulance Services 24X7" to IIT Hyderabad at your quoted rated INR 3,21,000 (Rs. Three Lakh twenty-one thousand) per month towards hire charges for supply of ambulance including drivers and Emergency Medical Technicians on duty shift 24hours basis for the first 1500KM in a month and subsequent charge for extra kms will be paid as per GeM Service Level Agreement for a trial period of 3months from 01.10.2025 to 31.12.2025. Further, you must comply with all the tender conditions and requirements subject to the satisfaction of doctors, failing which, the award stands cancelled.

If the services during the trail period are found satisfactory, the contract will be extended for the period of 9(nine) months. In Case the services during the trial period are not satisfactory, the contract will be terminated with three weeks' notice. The contract may be extended on a yearly basis up to three (3) years subject to satisfactory performance on the requirement of the institute.

As per the tender document, you are requested to deploy an ambulance along with the required human resources with effect from 01.10.2025 under intimation to this office. You are required to submit the credentials/resume and certificate of the Drivers (4No's) & (4No's). Non availability of the Ambulance/Driver/EMT and the required necessary equipment in an ambulance at any point of time without prior permission from the doctor on duty will attract penalty as per the tender document. This will be deducted from the monthly bill. Further, the contractor will be solely responsible for any untoward incident that occurred due to the non-availability of any services as per the tender agreement.

If the above offer is acceptable, you may give your acceptance letter within 7 days of the award of the contract, submit a Non-Judicial Stamp paper worth Rs.200/- (Rupees two Hundred only) for executing the contract agreement and also submit a Performance Security Deposit in the form of Bank Guarantee or Demand draft for Rs.2,45,000 (Rupees two lakhs forty five thousand only) from any nationalized Bank valid up to January 2028 in favor of the Director, IITH within 15 days of award of contract. In case your acceptance to undertake the above job contract is not received on or before 30.09.2025, the offer of the job contract is automatically cancelled.
