(Services provided by way of transportation of patient in an ambulance is wholly exempted from payment of GST in terms of Serial no. 74(b) of Notification no. 12/2017-and 9/2017 Central Tax (Rate), Dated 28.06.2017, read with the notification issued by the State Govt. under SGS T Act. Hence no GST is payable in this service.
