2. DELIVERY: The material should be dispatched within **22 Weeks** from the date of receipt of the Purchase Order. Please dispatch the items **BY AIR on Freight prepaid basis for Customs Clearance at Hyderabad, Telangana State, India.** The items may please be dispatched in the name of The Director, Indian Institute of Technology Hyderabad, Kandi, Sangareddy District, Telangana., India.

Our Imports are under Open General License Scheme as applicable to us vide Import Policy for 2015-20 of Government of India.

3. WARRANTY: Warranty should be provided for **24 months** from the date of supply, installation, commissioning and testing of the equipment. The defects, if any, during the warranty period are to be rectified free of charge by arranging free replacement wherever necessary. Any expenditure including statutory levies & To & Fro Shipping Charges on account of the replacement is to be borne by the supplier / agent.

4. Installation & Commissioning: Installation & Commissioning, should be completed within one month of receipt of goods in IITH Stores, wherever applicable.

5. Payment Terms: 100% Advance payment against submission of Bank Guarantee will be made via Wire Transfer for value through our Bankers viz. Canara Bank, IIT Hyderabad Branch, (AD CODE 0243290-8170342) Kandi – 502 285 Sangareddy Dist., Telangana, India.

5.1. Bank charges: All the bank charges within India from IIT Hyderabad account and beyond India all the bank charges from Vendor's account.

6. Documents: The set of Original shipping documents (Airway Bill, Invoice, Packing List, Guarantee Certificate) must be directly sent to our bankers **M/s Canara Bank, IIT Hyderabad Branch (3458)** & a duplicate set of shipping documents to be sent to us to enable speedy customs clearance.

7. Intimation of Shipment: Pre Alert Advice regarding AWB/BL copy, invoice, packing list, must be intimated to us (Email: office.stores@iith.ac.in, ar.purchase@iith.ac.in & ramakrishna.p@admin.iith.ac.in) and our customs clearing agent well in advance. 8. Liquidated Damages: If you fail to deliver the goods by the stipulated date, a sum equivalent to 1% of contract value for each week of delay or part thereof until actual delivery will be deducted from the contract value, as liquidated damages, subject to maximum deduction of 10% of contract value. Once the maximum is reached, termination of contract may be considered by IITH.

9. Risk Purchase Clause: If you fail to deliver the goods within the maximum delivery period specified, IITH may procure on such terms and in such manner as it deems appropriate. Goods or services similar to those undelivered and you are liable to IITH for any excess costs for such similar goods and services.

10. Penalty/Demurrage Charges: In case of demurrage/Penalty for delay in filing Bill of Entry due to wrong shipment papers, due to delay in intimation about the dispatch of shipment, Custom Queries or if the flight arrives on holidays (Sat & Sun) or any other reason not attributable to IITH and Custom Clearing Agent. The demurrage/Penalty charges will be borne by Supplier/Indian Agent

11. Arbitration:

- a) Unless otherwise specified, in all cases of disputes which cannot be settled by mutual negotiations, the disputes or differences shall finally be settled and binding on both parties by arbitration in conformity with the rules of Indian Arbitration and Conciliation Act 1996. All disputes or differences whatsoever arising between the parties out of relating to the construction, meaning and operation or effect of the general terms and conditions including the Purchase Order or the breach thereof shall be binding on the parties.
- b) Performance of the Purchase Order shall continue during arbitration and any subsequent proceedings.
- c) The jurisdiction and venue of arbitration shall be Hyderabad. The Arbitrator will be the Director, IITH or his nominee.
