INSTRUCTIONS FOR ONLINE BID SUBMISSION

The Tender Document can be downloaded from https://mhrd.euniwizarde.com OR Institute website-https://iith.ac.in/tenders.

The bidders are required to submit soft copies of their bids electronically on the https://mhrd.euniwizarde.com using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the Portal, prepare their bids in accordance with the requirements and submitting their bids online.

GUIDELINES FOR REGISTRATION:

- 1.Bidders are required to enrol on the e-Procurement Portal with clicking on the link "Online Bidder Enrolment" on the e-tender Portal by paying the Registration fee of Rs.2000/- +Applicable GST.
- 2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication with the bidders.
- 4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Only Class III Certificates with signing + encryption key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile. Or bidders can contact help desk for getting the DSC.
- 5. Only valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6. Bidder then logs in to the site through the secured log-in by entering their user ID /password and the password of the DSC / e-Token.
- 7. The scanned copies of all original documents should be uploaded in pdf format on portal https://mhrd.euniwizarde.com
- 8. After completion of registration payment, bidders need to send their acknowledgement copy on help desk mail id helpdeskeuniwizarde@gmail.com for activation of their account.

SEARCHING FOR TENDER DOCUMENTS

- 1. There are various search options built in the e-tender Portal, to facilitate bidders to search active tenders by several parameters.
- 2. Once the bidders have selected the tenders they are interested in, you can pay the form fee and processing fee (NOT REFUNDABLE) by net-banking / Debit / Credit card then you may download the required documents / tender schedules, Bid documents etc. Once you pay both fee tenders will be moved to the respective 'requested' Tab. This would enable the e- tender Portal to intimate the bidders through e-mail in case there is any corrigendum issued to the tender document.

PREPARATION OF BIDS

- 1. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid.
- 3. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF formats. Bid Original documents may be scanned with 100 dpi with Colour option which helps in reducing size of the scanned document.
- 4. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, GST, Annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Documents" available to them to upload such documents.
- 5. These documents may be directly submitted from the "My Documents" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- 1. Bidder should log into the website well in advance for the submission of the bid so that it gets uploaded well in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document as a token of acceptance of the terms and conditions laid down by IIT Hyderabad.
- 3. Bidder has to select the payment option as "e-payment" to pay the tender fee / EMD as applicable and enter details of the instrument.

- 4. In case of Bank Guarantee (BG) bidder should prepare the BG as per the instructions specified in the tender document. The BG in original should be posted/couriered/given in person to the concerned official of IIT Hyd before the Online Opening of Technical Bid. In case of non-receipt of BG in original by the said time, the uploaded bid will be summarily rejected.
- 5. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BOQ file, open it and complete the white Colored (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.
- 6. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 7. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8. Upon the successful and timely submission of bid click "Complete" (i.e. after Clicking "Submit" in the portal https://mhrd.euniwizarde.com), the portal will give a successful Tender submission acknowledgement & a bid summary will be displayed with the unique id and date & time of submission of the bid with all other relevant details.

TERMS & CONDITIONS

- 1. It may kindly be noted that your bid should:
- a) Single Part
- 2. The acceptance of the quotation will rest with the competent authority, who does not bind himself to accept the lowest quotation and reserves the right to himself to reject, or partially accept any or all the quotations received without assigning any reason.
- 3. Price quoted should be as per the BoQ and valid for a minimum period of 60 days from the date of opening of the quotation. The rate quoted should be free delivery at IITH Stores, Kandi 502284.
- 4. Complete specification with manufacturer's name and address should be given while quoting. Literature/Pamphlets should also be enclosed wherever applicable
- 5. In cases of agents quoting on behalf of the manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/dealer. There can be only one bid from the following:
 - i) The manufacturer directly or through one agent on his behalf; or
 - ii) Agent on behalf of only one principal.
- 6. 18. Public Procurement (Preference to Make in India), Order 2017:

a) IIT Hyd shall compare all substantially responsive bids to determine the lowest valuated bid. This Institute is following and abide with the Public Procurement (Preference to Make in India), Order 2017, DIPP, MoCI Order No. P-45021/2/2017-B.E.II dated 15th June 2017 and its subsequent amendments. Accordingly preference will be given to the Make in India products while evaluating the bids, however,

it is the sole responsibility of the bidder(s) to specify the product quoted by them is of Make in India product along with respective documentary evidence as stipulated in the aforesaid order in the technical bid itself.

- b) As per the above order and its subsequent amendments "Local Content" means the amount of value added in India which shall be value of the item procured (excluding net domestic indirect taxes) minus the value of the imported content in the item (including all the custom duties) as a proportion of the total value, in percent. Accordingly the suppliers will be classified in following categories.
 - i) Class I local Supplier has local content equal to or more than 50%
 - ii) Class II local Supplier has local content more than 20% but less than 50%
- c) **Verification of Local Content**: The Class I Local Supplier /Class II Local Supplier at the time of bidding shall be required to indicate the percentage of local content and provide self-certification as per Annexure D that the items offered meet the local content requirement. The details of the location(s) at which the local value addition is made also needs to be specified.

The bidders can be debarred for a period up to two years as , per Rule 151(iii) of GFR 2017, in case of false declaration.

Complaint Redressal Mechanism:

In case any complaint received by the procuring agency or the concerned Ministry/Department against the claim of a bidder regarding local content/domestic value addition in a product, the same shall be referred to competent authority at IITH or the relevant Ministry.

The bidder against whom the complaint is received shall be required to furnish the necessary documentation in support of the domestic value addition claimed in the product to authority. If no information is furnished by the bidder, such laboratories may take further necessary action, to establish the bonafides of the claim

A complaint fee of Rs. 2 lakh or 1% of the value of the domestically manufactured products being procured (subject to a maximum of Rs.5 lakh), whichever is higher, to be paid by Demand Draft to be deposited with Procuring Institute. In case, the complaint is found to be incorrect, the complaint fee shall be forfeited. In case, the complaint is upheld and found to be substantially correct, deposited fee of the complainant would be refunded without any interest.

False declarations will be in breach of the Code of Integrity under Rule 175 (1)(i)(h) of the General Financial Rules for which a bidder or its successors can be debarred for up to two years as per Rule 151 (iii) of the General Financial Rules along with such other actions as may be permissible under law.

19. ARBITRATION: a) Unless otherwise specified, in all cases of disputes which cannot be settled by mutual negotiations, the disputes or differences shall finally be settled and binding on both parties by arbitration in conformity with the rules of Indian Arbitration Act, 1940. All disputes or differences what so ever arising between the parties out of relating to the construction, meaning and operation or effect of the general terms and conditions including the Purchase Order or the breach thereof shall be settled by Arbitration Act, 1940 and the award made in pursuance thereof shall be binding on the parties.

ANNEXURE A

TECHNICAL SPECIFICATIOS

ATR-FTIR System Specifications

System Optics

- 1. The **sealed and desiccated** spectrometer with the rechargeable desiccant canisters and accessible with no need to open the spectrometer. The system must have a humidity indicator inspection window.
- 2. **Interferometer** must be a dynamically aligned, frictionless Michelson design. The interferometer must be capable of **spectral resolution better than 0.25 cm-1** and the spectrometer must have a motorized aperture at the source, for optimal peak shape collection of data. The instrument must be having better than **50000:1 peak to peak** signal to noise, per minute, measured at 4 cm-1. The **wavelength precision** must be within 0.0008 cm-1 with no need for software calibration and the wavelength accuracy must be minimum 0.02 cm-1 at 2000 cm-1 or better.
- 3. The interferometer standard beamsplitter must be KBr / Germanium coated, optimized for medium infrared spectral range. The **spectral range must be 7800-350 cm-1** or better.
- 4. The instrument must be equipped with smart accessories like ATR with automatic recognition and experiment setup. The ATR accessory must have **Diamond crystal plate with minimum 5 years of warranty including optical base module**. The instrument must have integrated touch panel and multicolor status indicator.
- 5. The **source** must be externally mounted and accessible without opening the instrument cover and with warranty of **at least 10 years**.
- 6. The laser must be stable and having long-life. It should be solid-state, temperature controlled diode laser with warranty of **minimum 10 years.**
- 7. The spectrometer must **include a Performance Verification** motorized wheel. The wheel must provide beam attenuation filters, NG-11 glass for detector linearity test and NIST-traceable 1.5 MIL (38 microns) polystyrene film. The validation wheel must be serialized and labeled with expiration date information. The Inbuilt NIST-traceable 1.5 MIL polystyrene film must be serialized. Automated performance verification as per ASTM E1421 to meet ISO/GLP requirements must be provided. The system suitability tests for complete system performance assurance must be given.
- 8. The system must have provision for optional **external beam** for additional sampling modules or infrared microscopes capability.
- 9. The **standard detector** must be a shielded DTGS room temperature stabilized. The spectrometer electronics must be compatible with MCT-A liquid nitrogen-cooled detectors.
- 10. The spectrometer must be compatible with additional **external modules** as a second sample compartment with provision for DTGS or MCT detector. Second sample compartment must be supportive for ATR, DRIFT, TG-IR, NIR experiments.
- 11. The instrument must come standard with a minimum **10-years warranty on infrared source, interferometer and laser.**
- 12. The minimum of 12 months full-system on-site warranty coverage must be provided
- 13. The power and other electrical requirements for the instrument for its efficient functioning must be mentioned. The power cord and adapter must match with Indian system.

- 14. The Standard Purge System Including the Purge Regulator, tubing and spectrometer attachment must be provided
- 15. Desiccant Replacement Package must be provided
- 16. A minimum of 10-ton KBr pellet preparation kit (includes Press, mortar & pestle, die set, pellet holder, KBr powder) must be provided

Software

Software must be **Windows 10 or higher version compatible** and must include:

- 1. Live display data collection, parameter set-up and spectral data preview. Customizable toolbar, menu, and options with user logins and password protection. Display capabilities: zoom, roll, stack, overlay, offset and interactive display tools. Data processing: baseline correction (automatic and manual), smooth, blank and straight line, first and second derivative, curve fitting, spectral math, subtract (manual and automatic). Data conversion and corrections: Kubelka Munk, Kramers Kronig, Spectral Search: high-resolution library generation, customizable information fields, single or multi-region search, library management, with over 30000 spectra in included libraries. Spectral peak labeling, audit trail history log, multiple data converters for JCAMP-DX and other vendor's spectral data files and user libraries. Spectral group statistical analysis: variance, average, and range. Peak analysis tools: peak area, peak height, cursor, annotation. Automatic atmospheric suppression to remove H2O and CO2 interferences (no standards needed).
- 2. **ATR correction** including settings for crystal material, reflections, angle and sample refractive index. ATR correction must support use of transmission mode libraries. In addition, polymer ATR libraries must also be provided.
- 3. **System Performance Verification** for automatic monitoring of system status including: Hardware Diagnostics to ensure key system components are working properly; Performance Verification, based on ASTM E1421, to test and document system operation; System Suitability to ensure analysis consistency, including sampling accessory; Spectral Quality Checks to ensure consistent spectral quality; Scheduled Maintenance monitor with operator warnings when Preventative Maintenance is due.
- 4. **Quantitative and qualitative** method development and analysis including: Beer-Lambert calibration and prediction (peak height or area integration). Classical Least Squares calibration and prediction. Discriminant analysis, Partial Least Squares (PLS) and Principal Component Analysis (PCR) prediction.
- 5. Infrared **spectral interpretation** with online interpretation guide.

Additional Multiple component mixture analysis software for **spectral identification and interpretation** must provide:

- 1. Advanced data management capability treating the entire hard drive as a database.
- 2. Multicomponent search for identification of mixtures in liquid, solid or gas phase, for up to four independent components. The software must provide the relative contribution of each compound in the mixture and generate a synthetic spectrum overlaid to the searched unknown spectrum.
- 3. FTIR licensed libraries from Polymer, plasticizers, additives, hydrocarbons, alcohols, phenols, aldehydes, ketones, esters, anhydrides, lactones, dyes, indicators, alkynes, nitro and azo compounds, phosphorous and sulphur containing compounds, inorganic, silanes (all spectra in high resolution format).
- 4. Peak search to identify materials by specific peak locations.
- 5. Spectral interpretation tools with functional group and compound classification.

Universal ATR accessory

The universal ATR accessory must provide the following capabilities:

- 1. **Diamond ATR crystal with 5-years warranty** protection against any physical or chemical damage, with spectral range down to 400 cm-1.
- 2. **Optional crystal disks** with Germanium crystal must be available for future upgradation which will be suitable for carbon-black filled materials;
- 3. **Optional reflectance** disk for coatings on metals reflectance studies.
- 4. Optical base ATR: High pressure tower with two tips plus volatiles cover and Automatic accessory recognition
- 5. The **pressure tower** must come standard with clutch pressure-calibrated mechanism, to provide consistent and uniform spectral results. The pressure tower heads must be exchangeable with various tips to fit different types of sample (films, beads etc.)
