Instructions to the Bidders for Online Bid Submission

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, preparing their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: <https://eprocure.gov.in/eprocure/app>.

REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal ([URL: https://eprocure.gov.in/eprocure/app](https://eprocure.gov.in/eprocure/app)) by clicking on the link “Online bidder Enrollment” on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email addresses and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC’s to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID/password and the password of the DSC / e-Token.

SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective ‘My Tenders’ folder. This would enable the CPP Portal to intimate the bidders through SMS / e- mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black-and white option which helps in reducing the size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates, etc.) has been provided to the bidders. Bidders can use the “My Space” or “Other Important Documents” are available to them to upload such documents. These documents may be directly submitted from the “My Space” area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

Note: My Documents space is only a repository given to the Bidders to ease the uploading process. If Bidder has uploaded his Documents in My Documents space, this does not automatically ensure these Documents being part of Technical Bid.

SUBMISSION OF BIDS

- 5) Bidder should log into the site well in advance for bid submission.
- 6) Bidder should ensure that they can upload the bid in time i.e., on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 7) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 8) Bidder has to select the payment option as “offline” to pay the tender fee / EMD as applicable and enter details of the instrument.
- 9) Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date and time of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise, the uploaded bid will be rejected.

- 10) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- 11) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc., The bidders should follow this time during bid submission.
- 12) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128-bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 13) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 14) Upon the successful and timely submission of bids (i.e., after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 15) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

Technical Eligibility Criteria:

1. Bidders shall produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below:

Experience of having successfully completed similar works during the last 07 years ending the last day of the month previous to the one in which tenders are invited.

Three similar completed works each costing not less than Rs.17,74,190/- only or

Two similar completed works each costing not less than Rs.26,61,284/- only or

One similar completed work costing not less than Rs.35,48,380/- only.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of tender.

“Similar Work” shall mean the work of SITC (Supply, Installation, Testing and commissioning) of Mechanical Air-Ventilation System/Ductable Exhaust systems/Staircase & Lift Pressurization system/HVAC ducting works i/c AHUs/CSUs/FCUs in any Institutional Campus/Labs/Industries/ Universities/ Commercial complexes/Power Plants/Banks/PSUs/Data Centres/IT Companies/ Pharma Companies/Any Other Industries and Organizations.

2. **Turnover:** The Average annual financial turnover of the bidder should be at least **Rs.13,30,642/- only** during the immediate last **three (03)** consecutive financial years **ending 31st March 2025 or ending 31st March 2026**. The value of annual turnover figures shall be brought to current value by enhancing the actual turnover figures at simple rate of 7% per annum. The certificate from CA shall be attached with the bid.
3. **Banker's Certificate** from a Commercial Bank or **Net worth Certificate:**

4. The bidder shall have **Employees Provident Fund (EPF) enlistment** and proof of the same shall be attached along with the Technical Bid clearly showing the Provident Fund Code number.
5. To become eligible, the bidder shall have to furnish an affidavit as per **Form 'J'** of the NIT.
6. The bidder shall submit the **Indemnity bond** as per format provided in **Annexure-II**.
7. The bidder shall submit the **details of eligible similar nature of works** completed during the last

seven years ending previous day of last date of submission of tender as per the format enclosed as **Annexure-III**.

8. The bidder shall submit the **Performance report/Completion certificate of works** as per the format enclosed as **Annexure-IV** or any similar Standard format issued by the respective Client Department/Organization.
9. The Bidder shall submit the **Acceptance of Tender Terms & Conditions** per format provided in **Annexure-V**.
10. Agreement shall be drawn with the successful tenderer on prescribed Form which is available in the website: https://drive.google.com/file/d/19_LkFZ1leQb_3BznXQtinslcLISYVdbo/view **(with up to date correction slips if any)** Tenderer shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
11. The time allowed for carrying out the work will be as stated at para 1 from the date of start as defined in **Schedule 'F'** or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
12. **The site for the work is available.**
13. Tender documents consisting of plans, specifications, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the contractor whose tender may be accepted and other necessary documents can be seen for information at the above-mentioned website.
14. Applicants are advised to keep visiting the above-mentioned website from time to time (till the deadline for bid submission) for any updates in respect of the tender documents, if any. Failure to do so shall not absolve the applicant of his liabilities to submit the applications complete in all respects including updates thereof, if any. An incomplete application may be liable for rejection.
15. The contractor whose tender is accepted, will be required to furnish a **Performance Guarantee of 5% (Five Percent)** of the tendered amount within the period specified in Schedule F. This guarantee shall be in the form of Deposit at Call receipt of any scheduled bank/Banker's cheque of any scheduled bank/Demand Draft of any scheduled bank/Pay order of any scheduled bank or Fixed Deposit Receipts or Guarantee Bonds of any Scheduled Bank or the State Bank of India in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F'. including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor.
16. The description of the work is as follows:

Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and

maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

17. Tenders with any condition including that of conditional rebates shall be rejected forthwith.

19. The competent authority on behalf of the President of India does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
20. Canvassing whether directly or indirectly, in connection with tenderers is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
21. The competent authority on behalf of President of India reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
22. The contractor shall not be permitted to tender for works if his near relative is posted a Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Institute.
23. No Engineer of gazette rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractor's service.
24. The tender for the works shall remain open for acceptance for a period of Ninety (90) days from the date of opening of tenders/Ninety days from the date of opening of financial bid in case tenders are invited on 2/3 envelop system (strike out as the case may be) if any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications

in the terms and conditions of the tender which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the tenderer shall not be allowed to participate in the retendering process of the work.

25. (A) All taxes, Labor Cess etc., as applicable shall be borne by the contractor himself. The contractor shall quote his rates considering all such taxes including GST on works. Any recovery towards GST is notified by the competent authority, the same shall be effected and no claim what so ever shall be entertained by IITH. The contractor shall quote his rates accordingly.

(B) 2% as TDS amount of GST amount payable on the bills will be deducted as per the Govt. of India, Ministry of Finance, Department of Revenue notification vide No.65/39/2018-DOR, dtd: 14-09-2018.

26. *GST registration certificate of the state in which the work is to be taken up, if already obtained by the bidder.*

If the bidder has not obtained GST registration in the state in which the work is to be taken up or as required by GST authorities, then in such a case the bidder shall scan and upload following under taking along with other bid documents.

"If the work awarded to me, I/We shall obtain GST registration certificate of the state, in which work is to be taken up, within one month from the date of receipt of award letter or before release of any payment by IIT Hyderabad, whichever earlier, failing which I/We shall responsible for any delay in payments which will be due towards me/us on a/c of the work executed and/or for any action taken by IIT Hyderabad or GST department in this regard."

27. This Notice inviting Tender shall form a part of the contract document. The successful tenderer/contractor, on acceptance of his tender by the Accepting Authority shall within 15 days from the stipulated date of start of the work, sign the contract consisting of:-

- a) The Notice Inviting Tender, all the documents including additional conditions, specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading there to.

Before tendering, the Agency shall inspect the site of work and shall fully acquaint himself about the conditions prevailing at site, availability of materials, availability of land and suitable location for construction of godowns, stores and camp, transport facilities, the extent of lead and lifts involved in the work (over the entire duration of contract) including local conditions, as required for satisfactory execution of the work and nothing extra whatsoever shall be paid on this account.
2. The Agency shall at his own expense and risk arrange land for accommodation of labour, setting up of office, the storage of materials, erection of temporary work-shops, and construction of approach roads to the site of the work including land required for carrying out of all jobs connected with the completion of the work. In any case, **IIT Hyderabad (Institute) shall not permit setting up of labour camps within its premises.** If during construction it becomes necessary to remove or shift the stored materials shed workshop, access roads, etc. to facilitate execution of any other work by any other agency, the contractor shall do as directed by the Engineer-in-charge and no claim whatsoever, shall be entertained on this account.
3. It shall be deemed that the contractor shall have satisfied himself as to the nature and location of the work, transport facilities, availability of land for setting up of camp etc. The department will bear no responsibility for lack of such knowledge and the consequences thereof.
4. The Agency shall have to make approaches to the site, if so required and keep them in good condition for transportation of labour and materials as well as inspection of works by the Engineer-in-charge. Nothing extra shall be paid on this account.
5. The Agency shall at his own cost submit samples of all materials sufficiently in advance and obtain approval of the Engineer-in-charge. Subsequently, the materials to be used in the actual execution of the work shall strictly conform to the quality of samples approved by the Engineer-in-charge and nothing extra shall be paid on this account. The acceptance of any sample or material on inspection shall not be a bar to its subsequent rejection, if found defective.
6. The contractor shall at his cost, make all arrangements and shall provide necessary facilities as the Engineer-in-charge may require for collecting, preparing, packing forwarding and transportation of the required number of samples for tests for analysis at such time and to such places as directed by the Engineer-in-charge, and bear all charges and cost of testing unless specifically provided for otherwise elsewhere in the contract or specifications. The cost of tests shall be borne by the contractor/Institute in the manner indicated below (except for water):
 - a) By the contractor, if the results show that the material does not conform to relevant specifications and BIS codes or any other relevant code for which conformity test is carried out.
 - b) By the Institute, if the results show that the material conforms to relevant specifications and BIS codes or any other relevant code for which conformity test is carried out.
7. Materials used on work without prior inspection and testing (where testing is necessary) and without approval of Engineer-in-charge are liable to be considered unauthorized, defective and not acceptable. The Engineer-in-charge shall have full powers to require removal of any or all of the materials brought to site by contractor which are not in accordance with the contract, Specifications or do not conform in character or quality to the samples approved by the Engineer-in-charge. In case of default on the part of the contractor in removing rejected materials, the Engineer-in-charge shall be at liberty to have them removed at the risk and cost of the contractor.
8. The work shall be carried out in such a manner so as not to interfere/or effect or disturb other works being executed by other agencies, if any.

9. Any damages done by the contractor to any existing work or work being executed by other agencies shall be made good by him at his own cost.
10. The work shall be carried out in the manner complying in all respects with the requirement of relevant rules and regulations of the local bodies under the jurisdiction of which the work is to be executed and nothing extra shall be paid on this account.
11. The contractor shall maintain in good condition all work executed till the completion of the entire work entrusted to the contractor under this contract and nothing extra shall be paid on this account.

16. The contractor shall take all precautions to avoid all accidents by exhibiting necessary caution boards and by providing red flags, red lights and barriers. The contractor shall be responsible for any accident at the site of work and consequences thereof.
17. Labour Welfare Cess @ 1% shall be deducted at source from the bills of Gross value (which includes the cost of stipulated materials) of the work done and Government shall not entertain any claim whatsoever in this respect in this contract. The Labour cess will be deducted in conformity with the Govt. guidelines for Electrical works and Civil works accordingly.
18. The ESI and EPF Contribution on the part of the employer in respect of the contract shall be paid by the contractor.

19. The contractor shall obtain a valid licence under the contract labour (R A) Act, 1970 and the contract labour (Regulation and Abolition) Central Rules, 1971 before the commencement of the work, and continue to have a valid licence until the completion of the work. The contractor shall also comply with provision of the Inter- State Migrant Women (Regulation of Employment and conditions of service) Act 1979.
20. All tools, tackles, safety equipment and labours required for maintenance and testing works / AMC at all levels and heights shall have to be provided by the tenderer at no extra cost.
21. Spare parts used by vendor should conform to IS specifications as applicable.
22. Any damaged due to mishandling by the person deputed by the vendor shall have to be restored back to its original condition by the vendor at their own cost.
23. **The Defect Liability Period (DLP)/Guarantee Period of the executed works shall be minimum 24 (Twenty Four) months only from the date of satisfactory completion, as recorded by the Engineer-in- Charge.**

24. Payment of Running bills:

The running bills shall be submitted by the contractor as per the progress of work done at site. However, the following will be the basis of payment for the items claimed under running bills:

- a) Gross Payment to be made on supply of material at site: **70% of quoted rate.**
- b) Gross Payment to be made on installation of material at site: **15% of quoted rate.**
- c) Gross Payment to be made on satisfactory Testing & Commissioning of material at site: **15% of quoted rate.**

After receipt of the running bill at IITH, the contractor shall get the executed work and claimed quantities in bill checked and verified from the Engineer-In-charge or his authorized Engineer and after satisfactory verification of work executed at site, the payment to the contractor shall be released.

25. FAT Inspections; At the discretion of Engineer-in-Charge, the contractor shall arrange for FAT inspections of Ventilation Fans in the Manufacture's Works premises and all the testing arrangements shall be made as per relevant testing procedures and codes. All the boarding, lodging expenses related to this FAT for the IITH representative shall be borne by contractor under his scope of work.

TECHNICAL SPECIFICATION FOR SHEET METAL WORKS, GRILLS, DIFFUSERS ETC.

SCOPE:

The scope of this section comprises of the supply, erection, testing and commissioning of Factory fabricated sheet metal ducting, grills, diffusers, thermal insulation and other connected works with the air distribution system, conforming of these specifications and in accordance the Bill of Quantities.

1.1 SHEET METAL WORK (Factory fabricated duct)

- a. Ducts shall be made of either galvanized steel sheets or aluminium sheets. The galvanized steel sheets shall conform to I.S.277 - 1992.

All ducting for air conditioning and mechanical ventilation shall be manufactured through computer aided machine (CAM) which has automatic provision for plasma cutting for various profiles and with auto folding arrangements.

Further all specials like taper and transformation pieces, elbows, tees etc., shall also be manufactured through CAM machine with plasma profile cutting.

For all straight rectangular duct sections, the longitudinal joints shall also be restricted to two diagonally opposite edges/corners.

Raw Materials:

Ducting shall be fabricated out of coils of 6 feet wide or 4 feet wide, to avoid multiple longitudinal joints

Material should of the minimum gauge necessary to resist both deflection caused by internal pressure and vibration due to turbulent air flow. In this project, it is proposed to install supply air ducting system and return air ducting system. Hence the minimum gauge thickness shall be as given below:

The thickness of all four sides shall be determined by the thickness required for the longest side of the duct from the above table.

All duct work panels shall be formed out of full size and no joints will be allowed in the panels of any duct piece unless the panel's sizes is larger than the full sheet size (2400mmx 900 mm). All exposed ducts upto 600mm width within conditioned spaces shall have slip joints - no flanged joints. The internal ends of slip joints shall be in the direction of air flow.

Zinc Coating should be of 120 gms / Sqm. Where angle iron flanges are used.

- the metal duct shall be lapped by a minimum of 6mm across the flanges.
- All flanges shall be applied with 2 coats of zinc-chromate, silver or zinc paint (Red oxide is prohibited)
- Neoprene gaskets 6 mm thick shall be used between duct flanges in all duct installation and between the ducts and the angle iron supports/brackets.

Dimensional Accuracy and Tolerances.

All duct work dimensions should be as per approved drawings with a maximum tolerance of

- +/- 2% for sizes upto 500mm
- +/-1% for sizes upto 1000mm
- +/-0.5% for sizes 1000mm and above

At the same time all connecting sections must be dimensionally matched to avoid any gaps. Duct sizes refer to the clear space for air flow where internal insulation is used.

Documentation:

For each drawing, all supply of duct work must be accompanied by computer generated detailed bill of materials indicating all relevant duct sizes, dimensions and quantities. In addition, summary sheets are also to be provided showing duct area by gauge and duct size range as applicable.

All cutting, folding notching, beading, shearing operations must be done by machines (CAD/CAM equipment preferred) for accuracy of parts and speed of fabrication. Fabricator to supply brochures and other documentation showing list of equipment used, manufacturing processes involved and also Quality Assurance Plan for approval.

Only finished exterior surfaces of ducting will be taken as the area of ducting to be paid for by the department. Vanes, supports, wastage etc., will be deemed to have been accounted for in the rate indicated.

The duct fabrication and installation shall generally conform to I.S.655-1963 and as amended All fire rated duct work shall have a minimum of 2 hours fire rating and to the approval of local authorities.

The contractor shall provide and neatly erect all sheet metal work as shown on drawings or as may be required to carry out the intent of these specifications and drawings and this work shall meet with the approval of the Engineer-in-charge in all its parts and details.

All necessary allowances and provisions shall be made by the Contractor for beams, pipes or other obstructions in the building, whether or not the same are shown on the drawings. Where it is necessary to avoid beams or other structural work or plumbing or other pipes or conduits, the ducts shall be transformed, divided or curved to one side, the required area being maintained, all as approved or directed by the Engineer-in-charge.

- All metal work in covered spaces shall be erected in time to avoid any delay to other contractors on the building.
- Ducting over false ceiling shall be supported from slab above, or from beams. In no case shall the duct be supported from the ceiling hangers or be permitted to rest on a hung ceiling. The contractor shall provide for duct supports to be of the patented type "ANCHOR" fasteners or equivalent.
- If a duct cannot be run as shown on the drawing, the Contractor shall install the duct between the required points by any path available, subject to the approval of the Engineer-in-charge.
- All ducts shall be rigid and shall be adequately supported and braced wherever required, with standing seams, tees or angles of ample size to keep the ducts true to shape and to prevent buckling, vibration or breaking. The duct supports shall be provided at intervals not greater than 1500 mm. Install miscellaneous steel angles or channels as required for structural support of duct where building frame spacing does not coincide with the required hanger spacing.
- In areas having high humidity, duct work shall be fabricated without seams in bottom of duct for atleast 3m of duct run behind grilles and slope duct up away from grille/register.
- Weather Proofing: Ducts exposed to weather shall be soldered or caulked water-tight with silicon sealant. Where ducts pass through the roof, provide a 75mm deep water tight condensate pan. When ducts connect to outside wall louvers, pitch the ducts, so water will drain to louver and seal bottom joints and seams to air handling unit.
- All toilet raiser duct shall be of soldered seams and joints through gaskets

NOTES: Where ducting is supported from ceiling/roof slab, Anchor grip bolts shall be used to fasten the suspension rods (for duct supports) to the ceiling/roof slab. All civil works involved including the drilling of holes for fixing the grip bolts and any chipping and finishing of the ceiling/roof slab shall be carried out by the successful contractor at no extra cost. All duct joints shall be made tight and the interior surfaces shall be smooth. Seal joints on all duct work with non-flammable high velocity duct sealer . Duct-tape will not be allowed. Bends shall be made with radius not less than one-half of the width of the duct or with scientifically designed interior curved vanes, as approved. The vanes shall be so spaced that the aspect ratio of each of the individual elbows formed by the vanes will be about five.

- All sheet metal connections, partitions and plenums required to confine the flow of air and through the filters and fans, shall be constructed of 18 Gauge GSS, thoroughly stiffened with 25 mm x 25 mm x 3 mm angle iron braces, and fitted with all necessary doors as required by the Engineer-in-charge to have access to all parts of the apparatus. Doors shall not be less than 450 mm x 650 mm. All bolts, nuts, washers etc. used for duct joints shall be of GI and not MS.
- Where metal ducts of sleeves terminates in wood work, brick or masonry opening, tight joints shall be made by means of closely fitting heavy flanged collars.
- Doors shall be set in ducts and air plenums for access to pipes, dampers, coils, valves, etc.
- Rat proofing consisting of galvanized screen of 13mm x 13mm x 2.7mm diameter wire shall be provided in supply air ducts, at AHU/FAN outlets, in return air openings of AHU/FAN room, wall and above return air slits in conditioned space as required .
